Workshop 2: Cropping Systems and Cover Crops

This workshop will address field crops and vegetable systems on crop rotation; discuss the benefits of cover crops; cover crop characteristics and seed mixes; adapting cover crop management for differing purposes, soils, and farms; planting dates and methods; harvesting/grazing options; weed control/pest management; and termination. October 23-24 (tentative) 2018, Ithaca.







Workshop 3: Adaptive Nutrient Management for Soil Health

This workshop will focus on nutrient cycling; how soil biology impacts nutrient management; nutrient scavenging; fertilizer recommendations; modeling and tools; manure management and application. Late Winter 2019, site TBD.

Workshop 4: Eliminating, Reducing, or Modifying Tillage for Soil Health

Workshop 4 will cover the benefits of less tillage; no-till systems; planting green; tillage equipment; manure application equipment; equipment field demonstrations. August 2019, tentatively at Empire Farms Days, Seneca Falls.

Workshop 5: Customizing Soil Health Systems to the Farm and Farmer

In the final workshop we plan to cover the economics of soil health; grazing systems; communication skills and storytelling; preparation for participant education and technical assistance activities. The final course agenda is the most open of all the workshops and we will be looking for additional input on this course as the curriculum progresses. November 2019, site TBD.
