Resource Conservation Professionals' responses:

- Because you can't cover everything in this short time, you should consciously identify what you are going to cover as well as what you aren't going to cover.
- Just right. Enough to get word out. Not so much to bury us.
- I think this is a good place to start. I need more specific technical training.
- Think this could lead to future technical sessions w/ specific focus (i.e. soil quality, water quality)
- Many multi-day workshops repeat information. Everyday of this workshop brought new exciting adventures in cross-training opportunities! Super! Tired at end of day, yet brain spinning with contemplation.
- Lots of good info perhaps reduce scenario complexity unless more field time will be included in forthcoming sessions. Reduce formality of group discussions (less presentations between groups).

Organic Professionals' responses:

- The first farm visit didn't click. Good tour, good info but difficult to stay on task either filling our NRCS 3-page questionnaire or organic system plan questions.
- I think there was a very good mix of instruction time and interaction time between the professionals.
- 12-hour day (Wed) was too long.

Resource Conservation Professionals' responses:

- I can tell a lot of time and effort went into organizing and arranging the details. I appreciate all the effort and think it paid off.
- Lodging and common hotel would have provided more time after hours for participants to exchange information.
- The could be the beginning to a series of trainings.
- Stretch to include further technical training sessions.
- Perceived as an NRCS (SWCD) person, I was guided to attend the organic presentation. I would also like to attend the NRCS presentation. One body two places very difficult.
- Provide actual assessment sheet used by organic certifiers in order to help conservation
 professionals understand how inspectors/certifiers are taking info from producers to make
 certification decisions. This info will also help conservation professionals better understand
 balances behind checkboxes and not just balancing NRCS check boxes with organic producers
 assessment questions.
- Reduce the focus of some of the group discussions & activities to make more manageable even time constraints.

Organic Professionals' responses:

- More of it (training), then adding it to everyone's annual training & professional improvement plans at annual evaluation time.
- A little more time, just a little to really process all of the information.

Resource Conservation Professionals' responses:

- This is a great ntorduction. I need to know how to apply tech guide practices from an organic perspective.
- The reason I answered good as opposed to excellent is because I felt we were constantly being cut off. I know it's a hard balance to give the right amount of time but I felt there was too hard of a push to keep on time rather than learning all the material we possibly could. There should have been a little more time allowed for transition or discussion, etc. Also, some less structured evening time would have allowed for more relationship development.

- In talking with organic professionals in my group, I found confusion with OREVT-1 and how to interpret it. When describing this tool, discuss how questions on it are related to specific NRCS assessment tools such as RUSLE-2, SCI, pest management, nutrient management. Discuss w/ organic professionals in more detail how soil maps and understanding not only soil characteristics but soil genesis has on how soils react to different mgmt practices. I discussed concept of source





& transport with an organic professional to describe conservation & water quality protection concepts. This concept seemed to help understanding.

- Instructors need hand-out packet. Break on Wednesday pm (4:30-6pm) let us clean up after farm visit and answer emails, but may have been used to shorten length of day committed to training.
- I like the fact that we had exercises to do but were not required to rush through every item, preventing us from truly understanding what we did work on. This kept us from rushing through the process. If this doesn't make sense, call Mitch Cummings.
- Include Extension in cross training.
