

# **Bertrand Farm**

(Niles, Michigan)



Bertrand Farm is an educational farm. Our mission is to connect people with their food and nature in the hope of promoting ethical and environmentally sound agriculture practices. We run several programs to include all ages: Farm Camps for youth 4-10,a CSA cooperative for adults and Family fun at our pumpkin patch in October. Bertrand Farm also partners with Good Shepherd Montessori School, South bend, to offer a Farm to School program. Our programs also include cooking and preserving classes.

Bertrand Farm offers two different CSA membership peograms. The non-working membership is a 15 week minnimum starting early June and has an option for delivery. Our working CSA is a not for profit educational program. It works like a cooperative. We start in Feb. and March with a planning meeting to order seed and create calendars of work for the season. At this time a commitment is made for three hours of work per week on Wednesday or Saturday mornings. The farm is divided into 10 working areas, by crop. At least two memberships care for each area, one on Wednesdays and one on Saturday. All produce harvested is divided equally among workers on their work day.

1. What farming method do you use? For example: certified organic, organic (not certified), bio-intensive, or conventional (~ use of pesticides and chemical fertilizers).

Organic, not certified. Low-till. Started CSA in 2001.

2. How many hours per week do you typically work during the growing season?

15-25 hours per week just for the CSA.

3. How many hours per week do you typically work during the off-season?

10 - 20 hours per week just for the CSA.

4. How many full-time and/or part-time employees are needed to run the CSA?

1 full-time + other seasonal part-time depending upon CSA work contract.

5. How many acres are currently in vegetable and/or fruit production?

3 -5 acres are currently in production.

6. What is the maximum number of acres you might commit to vegetable and fruit production in a given year?

4 acres.

7. What is the maximum number of acres you might commit to livestock grazing?

.5 acre -- just enough for chicken pens.

8. What aspects of operating a CSA do you enjoy <u>most</u> and why?

Education, community, produce. I have a passion for sustainable farming. My father had cancer and began a nutritional cleansing program which got me really interested in organic produce.

9. What aspects of operating a CSA do you enjoy <u>least</u> and why?

Irresponsibility of some members who don't show up to work on scheduled days. *No Shows* tend to upset all of the CSA members.

10. Has your CSA been profitable for the past three years? (Yes/No)

No, the CSA has not been profitable during the past three years. Off-farm income and other farm program and events are needed to break-even.

We're still growing and acquiring needed skills and equipment.
