BACKGROUND: PATTERNS FROM PAST MEETINGS

These are some personal needs, challenges, and aspirations that have been shared by steering committee members and have a history of discussion in this group.

- Challenge of managing and executing many different kinds of labor to run a business.
- Challenge of accessing skilled and culturally competent labor.
- Challenge of paying competitive wages to attract and retain labor.
- Challenge identifying solid sources for farm inputs including compost.
- Experience of geographic and social isolation.
- Desire to be networked with intentional community for advice and support.
- Require logistics support to scale: transportation, aggregation, and storage of product.
- Interest in shared services and backend office support: bookkeeping and marketing.
- Interest in continued education and technical assistance to refine operations.
- Interest in unique branding and/or certification of farm and farm products.
- Interest in collective bargaining and understanding and setting market rates.
- Interest in achieving wholesale pricing rates on materials and equipment.

There are a plethora of challenges underneath each of these categories. The essential question before naming the root challenge would be to identify which of the 3 categories the cooperative will be designed to address, or if all 3 will be addressed. • I like the idea of producer and consumer owned cooperative models. Giving decision making power to those involved in the entire supply chain, provides more holistic equity and accountability towards the mission of the cooperative effort. Background & Priorities - describe what is important to the member.

- In the context of a producer/consumer member cooperative related to food production, there would be overlapping priorities for each class of member.
 - Both would prioritize the access to nutritionally rich foods.
 - Being able to make a living off production, would be important to producing members.
 - Diversity of product choice and knowing who is growing their food, would be important to consumer members.

- Consumer members may experience lapses in access to desired food items, resulting from the regional seasonality of the product.
- Producer members may confront adverse conditions that inhibit volume of production.
- Finding balance and cohesion with individual needs. Considering the dynamics of the whole cooperative model.

How are those challenges connected and/or related to each other?

• Climate variability impacts production and product availability. Farms spread throughout a region can help mitigate losses that may be incurred in one area.

- Bridging the distance that currently exist between steering committee members.



- Securing funding to begin/sustain the co-op

- Non committed members
- Members not being realistic and honest about establishing a co-op, i.e., their time/effort and availability to see the co-op through
- The inability to secure financing to establish the co-op

- The co-op being more profitable for the "greater good"; for everyone: affordable (lower cost) & more variety of goods/produce to consumers
- Coordinated effort; efficient logistics to deliver goods/produce
- Collaborated (joint effort) of all members & individual businesses to be more efficient and productive (as a whole - "co-op")

What are some potential impacts of the co-op on members broader communities?

- Positive impact: to realize greater success of co-op members: individual businesses; being more profitable by "moving - selling" more goods/produce
- Getting more goods to end users; especially underserved families/individuals, who otherwise would not have access or be able to afford goods/produce
- Promoting environmental friendliness and sustainability
