Know your Pesticides: protect yourself, your family, and the environment

Why?

The Wyoming office of US Geological Society (USGS) has been monitoring groundwater quality for many years. Recently, trends have been showing a decline in pesticide contamination in rural wells, while also showing a disturbing increase in pesticide contamination in wells located within municipalities.

Currently, the general public has no requirement to attend any form of training in order to purchase and apply general use pesticides. Our only opportunity to provide education to the general consumer is at the point of sale.

What?

We are looking for opportunities to provide training to retail employees who are selling these products and who are answering questions about product selection, proper use, and safety concerns. This will help employees feel more comfortable and confident, and help make for more informed customers. All with the end goal of increasing the general consumer's understanding of safe and proper pesticide use, to reduce misuse and to ultimately keep people, their families, and the environment safer.

Retail employee training:

Date, time, length of training, and topics covered can be costumized to your needs

Examples of topics which can be covered covered:

- Simple, step by step process to help customers choose a pesticide
- Demonstration/introduction to the kiosk that will be placed in-store
- Review of the products you sell and specific concerns to relay to customers
- Review of common questions you receive, as well as those we get in the Extension Offices
- Pesticide safety: sprayer calibration, personal protective equipment, pesticide label, etc




Requirements

Kiosk Information for Store Managers

Kiosk number_____

Starting up Articulate software/kiosk content:

- Turn on (power button, top left)
- Swipe up on screen/tap login to get to Desktop
- Open folder "Pesticide Kiosk..." on Desktop (two taps)
- Open "Launch_story" file (two taps)
- Once application has launched and is visible, close "Pesticide Kiosk" folder
 - Tap Folder icon at bottom of screen, in toolbar
 - Tap "X" in upper right to close

Other notes:

- Since these are touchscreens, they can be "sensitive" when being moved/placed or if the case is too tight. If you notice other applications/icons acting as if they are being touched, try adjusting the tablet within the frame by wiggling it around—we've been able to correct the odd "ghost" behavior by adjusting tablet placement within the kiosk case. We also added wooden dowels to better hold the tablet in place.
- External volume toggles on the tablets cannot be reached when the tablet is inside the case. To adjust the volume, use the "Speaker" icon in the system tray (lower right bottom of screen).

Key Points and Resources

Remember these steps when handling customer questions

- 1. Identify the problem: cause, location, affected plant, etc.
 - a. Define management options:
 - b. Is control needed?
 - c. Consider nonchemical alternatives.
- 2. Match pest type with pesticide type.
- 3. Direct customers to least-toxic products if a pesticide is desired.
- 4. Open and review the label with the customer:
 - a. Check that pest and site are listed.
 - b. Identify protective clothing and application equipment requirements.
 - c. Point out sections on cautions, storage, and disposal.
- 5. Be sure the customer has everything they need before they leave the store.


