In July of 2023, Dr. Matt Smith retired from Clemson University and from his role as Program Co-Coordinator for SC SARE. Dr. John Andrae (Associate Director for Clemson's Experiment Station) is the new 1862 Program Co-Coordinator. As of 2023, SC SARE Programs at SC State University (1890) and Clemson University (1862) will receive SARE funding *independently* and will *each* have their own program assistants.

Update from SC State University

On behalf of Dr. Joshua Idassi (SC State Program Co-Coordinator), Mark Nettles (SC State University) gave a brief talk regarding the progress of the SC State University SC SARE Program.

Forages and Livestock Systems resources

Dr. Liliane Severino da Silva (Clemson University) gave an informative presentation regarding existing and emerging/sustainable livestock forage systems in the southeast. Dr. Silva also shared the development of forage-based educational books (one of which was supported by SC SARE).

Open Discussion

After the initial presentations, the floor was yielded for open discussion. The IPM Program would like to focus on surveying growers in hopes of directly sampling what areas they desire help in. Award amounts for SC SARE grants were heavily discussed. The two SC SARE Programs receive a limited amount of funding each year. In order to make the most meaningful impact, state-wide, the Clemson SC SARE Program is tentatively asking applicants to limit their funding requests to \$1,200 - \$1,500. Some attendees felt that this amount was not enough to justify completing the current request for funding application from SC SARE. It should be noted here that the SC State University SC SARE Program has no such restrictions currently in place, and while there is collaboration between the universities, their SARE Program funding is completely independent.

Concerning areas where SC SARE funding could be utilized in 2024, it was suggested (and agreed upon by many in attendance) that funding could be offered to train-the-trainer activities surrounding Climate Smart conservation practices, with regards to the new <u>Climate Smart Commodities Project</u>. This would facilitate collaboration between Climate Smart and SC SARE, allow for the state-wide standardization of educational materials, and effectively leverage Extension resources from both 1890 and 1862 land grants.

Other areas suggested as priority for 2024 trainings included:

- Hemp fiber & grain production
- The agronomics of forages (sprayer calibration, planning, planting, etc..)
- No-till conservation tillage and IPM basics for community gardens.
 - This training would be for extension agents who would then use that information to train growers.
- Wildlife management/Nuisance wildlife & pest management
 - There is a pressing, unrecognized need for proper trainings related to the handling of nuisance wildlife in agronomic systems (deer, wild hog, beaver, ground hog, etc.). With the onset of urban-sprawl-driven deforestation, wildlife is being increasingly displaced and their displacement into farm lands negatively impacts crop yields and interrupts IPM strategies growers may have in place.
- Farm machinery trainings
- Grant-writing workshops.

It was also mentioned that many of these topics could be expanded into webinar series, which would expand the impact of the trainings.

In closing, during the open discussion an emphasis was made that the SC SARE Program is strictly a professional development program (PDP) grant. This grant comes with restrictions, the primary limitations being that PDP funds MUST be used for trainthe-trainer activities and that said activities MUST have a sustainability component. Awardees of the SC SARE Program are free to apply for additional funding from both the National SARE Program and the Southern SARE Program, both of which offer a variety of grants.
