FARROW FARMS


raise piglets, sell at an agreed rate to grower farms.

GROWER FARMS

raise pigs to an agreed upon weight/time/etc. Sells finished pig to Coop.

KPPA COOP

Buys Pigs from Grower Farms, manages processing into charcuterie, owns finished product. Sells finished product nationally/retail.



Farrow Farms - earn from selling piglets to grower farms, may purchase finished product from KPPA Coop for resale. May earn payout from KPPA retail sales.

Grower Farms - earn from selling finished pigs to Coop, may purchase finished product from KPPA Coop for resale. May earn payout from KPPA retail sales.

CO-OP - earns from farm memberships, farm certifications and retail sales of finished product.

PROPOSAL:

The terms of the board officers (president, vice president, treasurer, and secretary) have expired. Because we are anticipating the need to expand and possibly split our boards as KPPA grows, we are proposing an extension of each officer's term for a period of 12 months. At that point, we will have developed an updated operating structure for EKPA and KPPA and will be able to hold elections for the necessary positions. We will space out terms for officers so that not all officers' terms expire in the same year.
