

mentorship, Beginning Farmers reported improvements to their KASA (*knowledge, attitudes, skills, or awareness*) in all categories.



\$39,999 in SARE funds → \$1.6 Million in USDA-TOPP Funds for Michigan

Transition to Organic Partnership Program (TOPP)

- 1. Mentorship
  - 30 mentor pairs per year in Michigan until 2027
  - My experience from this SARE project now informs 11 Midwest TOPP state projects
- 2. Technical Assistance (TA)
  - 2 Full Time Conservation District staff
  - MSU and 6 non-profits offering TA
- 3. Education
  - Workshops, field days and webinars
- 4. Community Development
  - 6 non-profits will each offer several networking events per year
- 5. Workforce Development
  - Jobs listings
