**Overview of the 2019 SC SARE Program.** Geoff Zehnder reviewed the SC SARE funding and planning process along with 2019 program activities and accomplishments, including training events organized by other organizations with SC SARE support. Top priority areas that were addressed in 2018 training events were:

- ***Bedding Down the Farm: Wrapping up the Growing Season and Preparing for Winter*** Half day SC New & Beginning Farmer Program (SCNBFP) event. Instructor, Dave Robb. January 5<sup>th</sup>, 2020. Clemson University Student Organic Farm. Clemson, SC.
- ***Developing an Online Presence for your Farm Business.*** (website and social media platform development). Full day SC New & Beginning Farmer Program (SCNBFP) event. 9am – 2pm March 1, 2019. Clemson, SC.
- ***Spring into Action: Early Season Preparations for Vegetable Production on the Farm.*** Half day SCNBFP event. March 20, 2019. Clemson University Student Organic Farm. Clemson, SC.
- ***Sandhill REC Field Day: Cover Cropping in Sandy Soils.*** Full day workshop. April 3, 2019. Sandhills Research and Education Center. Columbia, SC.
- ***Farmscaping for Beneficial Insects: Best Practices for Integrated Pest Management.*** One day SCNBFR workshop. April 30, 2019. Aiken, SC
- ***Integrated Weed Management.*** Full day training for farmers and ag professionals. May 23, 2019. Clemson Madren Center and CU Organic Research Farm, Clemson, SC.

### **Open Forum Discussion.**

Discussion focused on the following category areas for training: Pest Management, Soil Health, Livestock, and Other (discussion on Other included any additional topics pertinent to the growth of sustainable agriculture in the state not directly related to previous topics).

### **Advisory Committee Meeting: Prioritized Topic Areas for Training in 2020.**

Open Forum participants and Advisory Committee members reviewed topic areas identified in the Open Forum meeting and discussed priority topics by category. Members then cast votes for their top choice training topics to be included in the 2020 SC SARE

training program. AC members were allocated 5 votes total with one vote maximum per training topic.

- Establishment & Management of Beneficial Habitats (6 votes)
- Weed, Insect, Nematode Management (3 votes)

### **Livestock**

- Integrating Livestock into Diversified Vegetable Agriculture (including food safety) (9 votes)
- Pasture Management (0 votes)

### **Soil Health**

- Fertility Management (Organic amendments, calculations & timing, symptomology) (17 votes)
- Using Animals to Improve Soil Health (11 votes)
- Cover Cropping (profits, yield, soil health) (9 votes)
- Economics of Implementing Soil Health Practices (9 votes)
- Fundamentals of Soil Health (0 votes)
